

CATALOG OF MEASURES

ACCORDING TO THE STEP-BY-STEP PLAN OF THE HOST-AMPEL

The permanent crisis team has decided on the following risk-weighted catalog of measures to prevent the spread of the coronavirus SARS-CoV-2 on the basis of the Hochschul-Corona-Verordnung (HochschulCoronaVO M-V). This catalog of measures replaces the previous decisions of the crisis team. It will be published on the HOST Corona website. The measures apply from the specified date under the HOST traffic light on the HOST Corona website. Please continue to comply with the AHA-L rules!

NO ENTRY

There is a no trespassing policy at HOST for individuals who meet the following criteria:

1. **Persons suffering from COVID-19,**
2. persons who, according to the respective applicable criteria of the [Robert Koch Institute](#), **are close contacts who have an increased risk of infection.** The entry ban for close contacts does not apply if close contacts are
 - o Have been fully vaccinated against COVID-19 (as of day 15 after final vaccination),
 - o have recovered from COVID-19 disease confirmed by nucleic acid testing (PCR/NAT test) and have been vaccinated with one dose of vaccine (as of the day of vaccination); and
 - o have recovered from SARS-CoV-2 infection confirmed by nucleic acid testing (PCR/NAT testing) if the underlying testing was at least 28 days and no more than six months ago.
3. persons in whom
 - o An **antigen test** for direct pathogen detection of SARS-CoV-2 (antigen test), not performed or supervised by a health care professional or comparable person trained to do so, has a **positive result**,
 - o **signs of illness** are present that are suggestive of SARS-CoV-2 infection, such as: Fever, cough, shortness of breath, loss of sense of taste/smell, sore throat, runny nose, and aching limbs.
 - o **other health department orders** come into play. The general order for quarantine of contacts and suspected contacts, isolation of persons tested positive for SARS-CoV-2 coronavirus (AV Isolation) applies accordingly.
4. persons who are obliged to go into **domestic quarantine** according to the respective valid Entry Quarantine Ordinance (EQV).

Due to the great dynamics of the risk [areas according to the RKI](#), we ask you to follow them on your own responsibility. It is mandatory to comply with the quarantine requirements.
