

**Third Amending Statutes of the *Studienordnung* (Study Regulations)
for the Master's Degree Course Simulation and System Design
at Hochschule Stralsund University of Applied Sciences**

from 15 March 2021

Based on § 2(1) in conjunction with § 39(1) of the *Landeshochschulgesetz* - LHG M-V (State Higher Education Law), in the version announced on 25 January 2011 (Law and Ordinance Gazette of Mecklenburg-Vorpommern (GVOBl. M-V) p. 18), last amended by Article 6 of the law of 09 December 2020 (GVOBl. M-V p. 1364, 1368), Hochschule Stralsund, University of Applied Sciences (hereinafter UAS Stralsund) hereby passes the following amending statutes:

Article 1

The *Studienordnung* (hereinafter Subject-Specific Examination Regulations) for the Master's Degree Course Simulation and System Design at UAS Stralsund of 18 May 2017, last amended by the Second Amending Statutes of the Subject-Specific Examination Regulations for the Master's Degree Course Simulation and System Design of 13 October 2020 (date published on UAS Stralsund's homepage) is amended as follows:

1. § 8 paragraph 1 will be amended as follows:

- a) In the second table "Wahlpflicht/ Wahlmodule (elective modules)", in the third row with the designation "Modulnummer und Name (module code and name)" in the second to last column, "12" is deleted and replaced by "8". In the final column, "18" is deleted and replaced by "12".
- b) In the same place, in the ninth line labelled "WMSSDM 2800 Stability of Floating Systems", in the third column labelled "1. Sem.* (1st Sem.)", the information "0/0/3/1" is deleted and inserted into the fourth column labelled "2. Sem.* (2nd Sem.)".

2. § 8(2) a) Internship semester planned for the first subject semester will be amended as follows:

- a) In the first table "Modulnummer und Name (module code and name)", in the seventh row labelled "SSDM 1200 Applied Computer Science" in the fifth column, "0/0/0/2" is deleted and replaced by "0/0/2/2".
- b) In the second table "Wahlpflicht/ Wahlmodule (elective modules)", in the third row "3th" is deleted and replaced by "3rd".
- c) In the same place, in the fifth line labelled "WMSSDM 2100 Renewable Energy Technology", in the third column labelled "2. Sem.* (2nd Sem.)", the information "0/0/4/0" is deleted.
- d) In the same place, in the ninth line labelled "WMSSDM 2800 Stability of Floating Systems", in the fourth column labelled "3. Sem.* (3rd Sem.)", the information "0/0/3/1" is deleted.
- e) In the same place, in the tenth line labelled "WMSSDM 3000 Human Resources Management", in the third column labelled "2. Sem.* (2nd Sem.)", the information "0/0/4/0" is deleted.

3. Appendix 2 (module handbook) will be amended as follows:

- a) In the module table for “SSDM 6000 Scientific Work”, the thirteenth line labelled “Arbeitsaufwand / Work load” will be amended as follows:

- b) In the same place, in the second to last line labelled “Studien-/ Prüfungsleistungen/ Prüfungsformen”, the statement “Documentary work, 20 pages” is deleted and replaced by the statement “Belegarbeit 90 Stunden (Documentary work 90 hours)”.

Article 2

1. These amending statutes enter into force on the day after they have been published on UAS Stralsund’s website.

2. These amending statutes apply for the first time to students who enrolled for the master’s degree course Simulation and System Design at UAS Stralsund in summer semester 2021.
