

**Fourth Amending Statutes of the *Studienordnung* (Study Regulations) for the
Master's Degree Course Simulation and System Design at Hochschule
Stralsund University of Applied Sciences**

of 25 April 2024

Based on § 2(1) in conjunction with § 39(1) of the *Landeshochschulgesetz* – LHG M-V (State Higher Education Act) of Mecklenburg-Vorpommern, in the version announced on 25 January 2011 (Law and Ordinance Gazette of Mecklenburg-Vorpommern (GVOBl. M-V) p. 18), last amended by Article 1 of the Act of 21 June 2021 (GVOBl. M-V p. 1018), Hochschule Stralsund (hereinafter UAS Stralsund) hereby passes the following amending statutes:

Article 1

The *Studienordnung* (hereinafter Study Regulations) for the Master's Degree Course Simulation and System Design at UAS Stralsund of 18 May 2017, last amended by the Third Amending Statutes of the Study Regulations for the Master's Degree Course Simulation and System Design of 24 March 2021 (date published on UAS Stralsund's homepage), is amended as follows:

1. § 8(1) is amended as follows:

a) In the first table "Obligatory Modules", in the third last row labelled "SSDM 9000 Master's Thesis and Colloquium" in the last column labelled "ECTS-Punkte (points)", "27" is replaced by "24" and "3" is replaced by "6".

b) In the second table, "Elective Modules", the seventh row labelled "WMSSDM 2500 Automotive Lighting Engineering" and the ninth row labelled "WMSSDM 2800 Stability of Floating Systems" are deleted.

2. § 8(2) Item a) If the internship semester is planned for the first subject semester is amended as follows:

a) In the first table "Obligatory Modules", in the third last row labelled "SSDM 9000 Master's Thesis and Colloquium" in the last column labelled "ECTS-Punkte (points)", "27" is replaced by "24" and "3" is replaced by "6".

b) In the second table, "Elective Modules", the seventh row labelled "WMSSDM 2500 Automotive Lighting Engineering" and the ninth row labelled "WMSSDM 2800 Stability of Floating Systems" are deleted.

3. § 8(2) Item b) If the internship semester is planned for the third subject semester is amended as follows:

a) In the first table "Obligatory Modules", in the third last row labelled "SSDM 9000 Master's Thesis and Colloquium" in the last column labelled "ECTS-Punkte (points)", "27" is replaced by "24" and "3" is replaced by "6".

b) In the second table, "Elective Modules", the seventh row labelled "WMSSDM 2500 Automotive Lighting Engineering" and the ninth row labelled "WMSSDM 2800 Stability of Floating Systems" are deleted.

4. Appendix 2 (module handbook) is amended as follows:

a) In the table for the module "SSDM 9000 Master's Thesis and Colloquium", in the 14th row labelled "ECTS-Punkte/ECTS credit points", the number "27" is replaced by "24" and "3" is replaced by "6".

b) The tables for modules "WMSSDM 2500 Automotive Lighting Engineering" and "WMSSDM 2800 Stability of Floating Systems" are deleted.

Article 2

1. These amending statutes enter into force on the day after they have been published on UAS Stralsund's website.
2. These amending statutes apply for the first time to students who enrolled for the master's degree course Simulation and System Design at UAS Stralsund in winter semester 2024/2025.
